TYPES OF CASES:

Civil 1 cases are asbestos cases, toxic mass torts and other more complex civil cases

(added to the civil 1 calendar by motion).

Civil 2 cases are all other civil cases, except for those under \$5000 which go to the small claims court.

Felony 1 – murder, 1st degree sexual assault, and complex litigation involving wiretaps or conspiracies

Accelerated Felony Trial Calendar (AFTC) – these calendars are comprised of cases in which defendants have been charged with violent crimes and are being detained (held in jail) pre-trial.

Felony 2 – all other felonies

Misdemeanor – those crimes with a maximum penalty up to 1 year.
